



1. Summary of significant accounting policies

General information and basis of preparation

The annual financial statements comprising the Balance Sheet and the related notes constitute the individual financial statements of Soul Fuel Limited for the financial year ended 31 December 2025.

The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 105 "The Financial Reporting Standard applicable to the Micro entities Regime" issued by the Financial Reporting Council (FRC) and promulgated by the institute of Chartered Accountants in Ireland. The company qualifies as a micro company for the period, as defined by section 280D of the Act, in respect of the financial period and has applied the rules of the 'Micro Companies Regime' in accordance with Section 280E of the Act and FRS105.
