**1. GENERAL INFORMATION**

Farnham Properties Limited is a company limited by shares incorporated and registered in Ireland. The registered number of the company is 424829. The registered office of the company is The Orchard Centre, Drumalee Cross, Cootehill Road, Cavan, Co. Cavan, which is also the principal place of business of the company. The financial statements have been presented in Euro (€) which is also the functional currency of the company. The company is currently Dormant and has not yet commenced any business activity.
