1. General information

The company is a private company limited by shares, registered in Ireland. The address of the registered office is 65 Stillorgan Gate, Kilmacud Road Upper, Dublin 14, D14F5C8.

2. Statement of compliance

3. Accounting policies and measurement bases

Basis of preparation

The financial statements have been prepared on the historical cost basis.

The financial statements are prepared in Euro, which is the functional currency of the entity.

Turnover

Turnover is measured at the fair value of the consideration received or receivable for goods supplied and services rendered, net of discounts and Value Added Tax.
