Opinion

NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial year ended 30 June 2025

1. General Information

Irish Pig Health Society Company Ltd by Guarantee is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 597468. The registered office of the company is Ground Floor, 71 Lower Baggot Street, Dublin 2. The company has been set up to promote activities in pig farming sector and to organise an organisational annual event. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the financial year ended 30 June 2025 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

Income

Revenue comprises the membership subscription fees. There were sponsorship incomes received from Green Acre Marketing as the society annual event took place during financial year (8th April 2025).

Investments

Investments held as fixed assets are stated at cost less provision for any permanent diminution in value. Income from other investments together with any related withholding tax is recognised in the Income and Expenditure Account in the financial year in which it is receivable.

Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Taxation and deferred taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable income for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more tax in the future, or a right to pay less tax in the future. Timing differences are temporary differences between the company's taxable income and its results as stated in the financial statements.

Deferred tax is measured on an undiscounted basis at the tax rates that are anticipated to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the Balance Sheet date.

5. Prior Year Adjustment

The comparative year financial information has been adjusted to reflect the recognition of income in relation to the annual society event, held in April/May each year, notwithstanding the respective income net of attendant costs are not received until post year end. Due to an administrative oversight, the income for the annual event was booked on a receipts basis rather than an accruals basis in recent years. To bring the financial statements into line with financial reporting standards, there is income of €41,866 and respective costs of €16,900 in relation to April 2024 event, recognised as accrued income and accrued expenditure in the revised financial information for the comparative financial year ended 30 June 2024, with the net adjustment to current year opening reserves of €24,966. Further was an adjustment of €24,775 to the opening balance Reserves in the comparative year ended 30 June 2024 in relation to the previous year adjustments.


