

NOTES TO THE FINANCIAL STATEMENTS

For the Financial Year ended 22 June 2025

1. General Information

Pickerings Lifts Limited (“**the Company**”) is a company limited by shares and was incorporated and registered with the Companies Registration Office on 23rd June 2017 in the Republic of Ireland with a registered office at Unit 3D North Point House, North Point Business Park, New Mallow Road, Cork.

2. Accounting Policies

The financial statements have been prepared under the historical cost convention unless otherwise specified in these accounting policies and in accordance with Section 1A of the Financial Reporting Standards 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2014.

The preparation of financial statements in compliance with FRS102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the Company’s accounting policies.

The Company is not trading, and no significant judgements or estimates have been applied during the financial year.

The functional currency is Euro (€).
