**I. General information**

Thornton Advisers Limited is a private company limited by shares (registered under Part 2 of Companies Act 2014), incorporated in the Republic of Ireland. The Registered Office is 48 Stillorgan Park, Blackrock, Co Dublin, which is also the principal place of business of the company. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

**2. Summary of Significant Accounting Policies**

**Basis of preparation**

The financial statements have been prepared on the going concern basis and in accordance with the historical cost cost convention. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 105 "The financial Reporting Standard applicable to the Micro-Entities Regime" issued by the Financial Reporting Council.

The company qualifies as a micro company as defined by Section 280D of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Micro Companies Regime in accordance with section 280E of the Companies Act 2014 and FRS 105.

**Trade and other Debtors**

Trade and other Debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad debts.

**Trade and Other Creditors**

Trade and other payables are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method.

**Taxation**

Current tax represents the amount expected to be paid or recovered in respect of taxable profits for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Statement of Financial Position date.

**Ordinary Share Capital**

The ordinary share capital of the company is presented as equity.
