DIRECTORS' RESPONSIBILITIES STATEMENT

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable Irish law and regulations.

Opinion

We have audited the financial statements of Abbey River Court Owners' Management Company CLG ('the company') for the financial year ended 20 December 2025 which comprise the Income and Expenditure Account, the Balance Sheet, the Reconciliation of Members' Funds, the Cash Flow Statement and the related notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", issued in the United Kingdom by the Financial Reporting Council, applying Section 1A of that Standard.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 20 December 2025 and of its surplus for the financial year then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", applying Section 1A of that Standard; and

NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial year ended 20 December 2025

1. General Information

Abbey River Court Owners' Management Company CLG is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 379160. The registered office of the company is M&C Property, 9 Lower Cecil Street, Limerick. Abbey River Court Owners' Management Company CLG is established for the purposes of taking ownership of, and managing, maintaining and repairing the common areas of the development at Abbey River Court, Sheep Street, Limerick. The company meets the definition of an owners management company under the Multi-Unit Developments Act 2011. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the year ended 20 December 2025 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

Income

Income represents service charges and sinking fund contributions received and receivable from unit holders/tenants for the year. Service charges are billed in accordance with Section 18 of the Multi-Unit Development Act 2011. For unit/holder tenants where collectibility is not assured, revenue is recognised when it is probable that the economic benefits associated with the transaction will flow to the company. A provision for bad and doubtful debts is recognised where directors deem that collectibility is not assured.

Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and in hand, demand deposits with banks and other short-term highly liquid investments with original maturities of three months or less and bank overdrafts. In the Balance Sheet bank overdrafts are shown within Creditors.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Taxation

The company is exempt from Corporation Tax due to its status as a not for profit management company. A concession to filing Corporation Tax returns is made to a company whose income is service charges collected from property owners and whereby this money is used in total to cover the day to day expenses incurred in maintaining common areas.

Sinking Fund Contributions

In accordance with Section 19 of the Multi - Unit Development Act 2011, the company must establish a sinking fund to fund non-routine maintenance and other non-routine costs that may arise from time to time. The Sinking Fund is not guaranteed to cover all unexpected costs of a non-recurring nature. These funds are held in a separate designated bank account and are allocated to a special reserve titled "sinking fund reserve". Sinking fund contributions are recognized as income in the Income and Expenditure account in the period in which large, non-regular repair and maintenance work is undertaken. The company has set up a separate designated bank account, and contributions have been made to same. Further transfers may be made to the sinking fund from liquid resources in each financial period.

3. Common areas and location

The company maintains the common areas at Abbey River Court, Sheep Street, Limerick.

4. Service Charges

The annual service charge for the year ended 20 December 2025 for residential units was €2,370. There was also a sinking fund contribution of €200 per unit.

5. Insurance

The company insurance policy is held with Everest Insurance (Ireland) DAC. The renewal premium on the policy for the year ended 30 April 2025 is €23,974. The insured value of the Buildings is €15,000,000, Public Liability of €6,500,000 and Employers' liability €13,000,000. Contents in common areas are insured to the value of €25,000 per block.

6. Employees

There were no employees apart from the directors, who did not receive any remuneration. (2024 - €Nil).
